

“In view of the above and following the order dated 11.3.2024 passed in W.P.No.25731 of 2023 and in items thereof, these Interlocutory Applications are ordered/ disposed of and the interim orders passed earlier in the above matters are hereby modified with a direction to the official respondents to proceed with transfers to the posts of School Assistants / Secondary Grade Teachers in Ranga Reddy District and promotions to the post of School Assistants on the basis of the seniority list, along with other Districts, as per their schedule issued in proceedings Rc.No.565/Ser.IV/2022-2 dated 07.06.2024. Further, to protect the interests of petitioners in W.P.Nos.25727 and 27382 of 2023, as an interim measure, the respondents are directed to keep (40) posts of School Assistants vacant in their respective subjects.”


